Privacy Policy

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

- **You** means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Legal Compass The Journal .
- **Affiliate** means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.
- **Account** means a unique account created for You to access our Service or parts of our Service.
- **Website** refers to Legal Compass The Journal , accessible from thelegalcompassjournal@gmail.com
- **Service** refers to the Website.
- **Country** refers to: United Kingdom

- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province,

country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

Data Protection Declaration

Introduction

We take the protection of your data very seriously. Any data that you make available via the website <https://www.thelegalcompass.co.uk> is collected and used in accordance with the applicable data protection regulations. This Privacy Policy only applies to the Legal Compass website. If you are forwarded to other pages via links on our pages, please seek more information on how your data is retained & processed by other providers.

1. General

Personal data are all data that can be related to you personally, e.g. name, address, e-mail addresses, user behaviour. The following regulations inform you about the type, scope and purpose of the collection, processing and use of your personal data. Responsible according to Art. 4 para. 7 EU General Data Protection Regulation (GDPR) is:

2. Automatic Data Collection

When using the website for informational purposes only, i.e. if you do not register or otherwise provide us with information, we only collect the personal data that your browser transmits to our server. If you would like to view our website, we collect the following data, which is technically necessary for us to display our website to you and to guarantee stability and security (legal basis is Art. 6 I S. 1 f GDPR): Your IP address, date and time of your website visit, time zone difference to Greenwich Mean Time (GMT), the content of the request (specific page), access status / HTTP status code, the amount of data transferred, the website from which the request came, the browser you are using, operating system and its interface as well as the name of your access provider, language and version of the browser software.

The data mentioned are processed by us for the following purposes:

- Ensuring a smooth connection to the website,
- Ensuring comfortable use of our website,
- Evaluation of system security and stability as well as for further administrative purposes.

This information is temporarily stored in a so-called log file. The information mentioned is recorded without any action on your part and stored until it is automatically deleted. In no case do we use the collected data for the purpose of drawing conclusions about you personally.

3. Information about cookies

We use cookies on our website. These are small files that your browser automatically creates and that are stored on your device (laptop, tablet, smartphone, etc.) when you visit our website. Cookies do not cause any damage to your device and do not contain viruses, Trojans or other malware.

Information is stored in the cookie that results in connection with the specific device used. However, this does not mean that we are immediately aware of your identity.

The use of cookies serves on the one hand to make the use of our offer more pleasant for you. We use so-called session cookies to recognise that you have already visited individual pages on our website. These are automatically deleted after leaving our site.

In addition, we also use temporary cookies to optimise user-friendliness, which are stored on your end device for a specified period of time. If you visit our site again to use our services, it is automatically recognised that you have already visited us and what inputs and settings you have made so that you do not have to re-enter them.

On the other hand, we use cookies to statistically record the use of our website and to evaluate it for you in order to optimise our offer. These cookies enable us to automatically recognise

when you visit our site again that you have already visited us. These cookies are automatically deleted after a defined period of time.

The data processed by cookies are required for the purposes mentioned to safeguard our legitimate interests and those of third parties in accordance with Art. 6 I S. 1 f GDPR. You can prevent cookies from being saved on your hard drive by selecting "do not accept cookies" in your browser settings. However, this can restrict the functionality of our offers.

4. Use of our Contact Form / Making Contact

If you have any questions, we offer you the opportunity to contact us using a form provided on the website or via our e-mail address. It is necessary to provide your name and a valid email address so that we know who sent the request and can answer it. Further information can be provided voluntarily.

The data processing for the purpose of establishing contact takes place in accordance with Art. 6 Para. 1 lit a GDPR on the basis of your voluntarily given consent. The personal data collected by us when you contact us will be stored after your request has been dealt with or processed in order to statistically evaluate it for marketing purposes and to optimise our offer. The legal basis is Art. 6 I S. 1 f GDPR. The respective statutory retention period applies for the duration of the storage of personal data. After the deadline has expired, the relevant data is routinely deleted, provided that it is no longer required to fulfil or initiate a contract.

5. Social media

In addition to our website, we maintain other online presences within social networks, in particular on Facebook, Twitter, YouTube and Instagram. These are only included on our website as links (coloured icons) to the corresponding services. After clicking on the integrated graphic, you will be redirected to the website of the respective provider, i.e. only then will user information be transmitted to the respective provider.

Your data is usually processed by these providers for market research and advertising purposes. User profiles can be created from their usage behaviour and the resulting interests, which can then be used to show advertisements inside and outside the platforms. As a rule, cookies are used for this purpose, in which your usage behaviour and interests can be saved. In addition, your profile can be used to infer your interests regardless of the devices you use, especially if you are logged into the respective platform.

We process your personal data on the basis of our interest in effective information and communication with you. The legal basis is Article 6 Paragraph 1 lit. f. GDPR. If you are asked for your consent to the data processing by the respective providers, for example by submitting the relevant declarations as part of the registration process, the legal basis for the processing is Art. 6 Para. 1 lit. a., Art. 7 GDPR.

With regard to the individual processing of your data and the corresponding possibilities of objection, we refer to the information provided by the providers linked below. If you want to assert information claims or other user rights, we point out that these can be asserted most effectively with the respective providers, as only these have access to the data of their users and can then meet their claims immediately.

7. Use of Google Analytics

This website does not as of yet use Google Analytics but reserves the right to do so in the future. In case Google Analytics are ever used in this website, please read how your data will be used. Google Analytics is a web analysis service from Google Inc. ("Google"). Google Analytics uses so-called "cookies," text files that are stored on your computer and that enable your use of the website to be analysed. The information generated by the cookie about your use of this website is usually transferred to a Google server in the USA and stored there. If IP anonymisation is activated on this website, your IP address will be shortened beforehand by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. The full IP address is only transmitted to a Google server in the USA and shortened there in exceptional cases. On behalf of the operator of this website, Google will use this information to evaluate your use of the website, to compile reports on website activity and to provide the website operator with other services related to website and internet usage.

The IP address transmitted by your browser as part of Google Analytics will not be merged with other Google data. You can prevent the storage of cookies by setting your browser software accordingly; however, we would like to point out that in this case you may not be able to use all functions of this website to their full extent. You can also prevent Google from collecting the data generated by the cookie and relating to your use of the website (including your IP address) and from processing this data by using a browser plug-in.

This website uses Google Analytics with the extension "_anonymizeIp ()". As a result, IP addresses are processed in abbreviated form, so that personal references can be excluded. If the data collected about you can be linked to a person, this will be excluded immediately and the personal data will be deleted immediately.

We use Google Analytics to analyse the use of our website and to improve it regularly. We can use the statistics obtained to improve our offer and make it more interesting for you as a user. For the exceptional cases in which personal data is transferred to the USA, Google has submitted to the EU-US Privacy Shield, <https://www.privacyshield.gov/EU-US-Framework>. The legal basis for the use of Google Analytics is Art. 6 I S. 1 f GDPR.

9. Rights of Data Subjects

You have the right:

- to request information about your personal data processed by us in accordance with Art. 15 GDPR. In particular, you can obtain information about the processing purposes, the category of personal data, the categories of recipients to whom your data has been or will be disclosed, the planned storage period, the existence of a right to correction, deletion, restriction of processing or objection, the existence of a The right to lodge a complaint, the origin of your data, if we have not collected it, as well as the existence of automated decision-making including profiling and, if applicable, meaningful information on their details;
- to immediately request the correction of incorrect or incomplete personal data stored by us in accordance with Art. 16 GDPR;
- to request the deletion of your personal data stored by us in accordance with Art. 17 GDPR, unless processing to exercise the right to freedom of expression and information, to fulfill a legal obligation, for reasons of public interest or to assert, exercise or defend Legal claims is required;
- to request the restriction of the processing of your personal data in accordance with Art. 18 GDPR, insofar as the accuracy of the data is disputed by you, the processing is unlawful, but you refuse to delete it and we no longer need the data, but you need to assert it Need to exercise or defend legal claims or you have objected to processing in accordance with Art. 21 GDPR;
- In accordance with Art. 20 GDPR, to receive your personal data that you have provided to us in a structured, common and machine-readable format or to request that it be transmitted to another person responsible;
- To revoke your consent given to us at any time in accordance with Art. 7 Para. 3 GDPR. As a result, we are no longer allowed to continue the data processing based on this consent in the future

To complain to a supervisory authority in accordance with Art. 77 GDPR. As a rule, you can contact the supervisory authority of your usual place of residence or work or our headquarters.

10. Right to object

If your personal data are processed on the basis of legitimate interests in accordance with Art. 6 I S. 1 GDPR, you have the right to object to the processing of your personal data in accordance with Art. 21 GDPR, provided there are reasons for this that arise from your particular Situation arise or the objection is directed against direct mail. In the latter case, you have a general right of objection, which we will implement without specifying a particular situation.

11. Data security

We use the popular SSL (Secure Socket Layer) method in conjunction with the highest level of encryption supported by your browser when you visit our website. Usually, this is 256-bit encryption. If your browser does not support 256-bit encryption, we use 128-bit v3 technology instead. You can tell whether an individual page of our website is transmitted in encrypted form from the closed display of the key or lock symbol in the lower status bar of your browser. The information that you transmit to us is generally stored on servers within Germany or at least the European Union.

We also use suitable technical and organizational security measures to protect your data against accidental or intentional manipulation, partial or total loss, destruction or against unauthorized access by third parties. Our security measures are continuously improved in line with technological developments.

12. Current status and changes to this data protection declaration
